



## NOTICE OF ELECTION, NOMINATION OF CANDIDATES AND CLOSING DATE FOR NOMINATIONS

### for the Northland District Health Board 2010 election

Under sections 52 and 53 of the Local Electoral Act 2001, I give notice that on Saturday 9 October 2010 the following election will be held under the single transferable voting electoral system by postal vote:

Election of seven members for the Northland District Health Board

#### NOMINATIONS

Each candidate must be nominated on the appropriate nomination paper obtainable during normal business hours from Friday 23 July from the following locations:

- **Far North District Council**, Memorial Avenue, Kaikohe
- **Kaipara District Council**, 42 Hokianga Road, Dargaville
- **Northland District Health Board**, Maunu House, Maunu Road, Whangarei
- **Whangarei District Council**, Forum North, Rust Avenue, Whangarei

Nominations of candidates must be in the hands of the electoral officer or one of the constituent territorial authority electoral officers or electoral officials at one of the following addresses not later than 12 noon on Friday 20 August 2010.

- **Far North District Council**, Memorial Avenue, Kaikohe
- **Kaipara District Council**, 42 Hokianga Road, Dargaville

Each nomination must be accompanied by a deposit of \$200 GST inclusive (payable by cash, cheque or eftpos) together with a Conflict of Interest Statement.

A candidate may submit a candidate profile statement with their nomination paper for sending out with the voting documents to electors. An attachment to the nomination paper outlines rules and procedures governing candidate profile statements.

#### ELECTORAL ROLLS

The electoral rolls to be used for this election close on Friday 20 August 2010, and can be inspected during normal business hours from Friday 23 July 2010 at the following locations:

Enrolment for inclusion on the Residents Electoral Roll is conducted through the Electoral Enrolment Centre of New Zealand Post. Applications for enrolment should be made through your local post shop.

Following closure of the rolls, the electoral officer of each constituent territorial authority may, on application of any person who is or claims to be entitled to be enrolled or any other person or otherwise, make any necessary corrections to the names, addresses, abbreviations, or marks appearing in the electoral roll.
