ISSUING OF VOTING DOCUMENTS

Voting documents will be posted to electors from Friday 17 September.

RETURN OF VOTING DOCUMENTS

Voting documents must be returned not later than 12 noon, Saturday 9 October 2010 to the respective constituent district council electoral officer.

Voting documents can be returned by post or hand delivered to the following constituent council offices between Friday 17 September 2010 and Friday 8 October 2010 during normal office hours, and Saturday 9 October 2010 between 9am - 12 noon:

- Whangarei District Council, Forum North, Rust Avenue, Whangarei;
- Far North District Council, Memorial Avenue, Kaikohe;
- Kaipara District Council, 42 Hokianga Road, Dargaville.

SPECIAL VOTING

Special voting in terms of the Local Electoral Act 2001 and the Local Electoral Regulations 2001 may be exercised at the above council offices and times.

A person can apply to enrol as a residential elector right up to and including 8 October 2010 – the day before the close of voting.

EARLY PROCESSING OF VOTING DOCUMENTS

The Northland District Health Board has resolved under section 79 of the Local Electoral Act 2001 to process voting documents before the close of voting.
