

Ka Pai Te Tai Tokerau COVID-19 Vaccination Campaign

Gift Draw Terms and Conditions

General Terms

1. The ka pai Te Tai Tokerau Campaign (“Campaign”) is conducted by Northland District Health Board. The campaign runs from 8:00am 1 October 2021 until 5pm on 10 December 2021 or when notified otherwise. If dates need to change, we will include notifications on Our website and Facebook page.

2. If You do not accept any of Our terms and conditions, you will be excluded from the draws.

Gifts will be drawn over 10 weeks:

Daily (Monday to Friday) gifts of 10x \$200 petrol vouchers and 10x \$50 Prezzy Cards

Every Friday a Northland travel voucher to the value of \$1,000 will be drawn

The Labour Weekend Draw includes 4x Apple watches, 2x iPhones, 1x e-bike, 2x Northland fishing charter trips, 10x \$250 Hunting and Fishing vouchers, a \$3,000 Northland travel voucher and a \$150 fuel voucher.

The Christmas Draw includes 2x \$6,000 Cook Island Holiday Package, 2x \$4,000 NZ holiday packages, 3x \$3,000 Northland holiday packages, 8x \$500 Xmas hampers, 10 x \$250 Hams, 24x \$250 Kmart vouchers, 24x \$250 Farmers vouchers, 24x \$250 Bunnings vouchers, 24x \$250 Mitre10 vouchers, 24x \$250 Four Square vouchers, 24x \$250 Countdown vouchers, 24x \$250 PAK'nSAVE vouchers, 24x \$250 New World vouchers, 24x \$250 Hunting and Fishing vouchers.

Eligibility

3. Only Northland residents who have been recorded in the COVID-19 Immunisation Register as having had at least one vaccine dose before 25 October 2021, will be included in the weekday and Friday draws, and the Labour Weekend draw up until 25 October. All Māori Health Provider, Northland DHB staff, primary care and community health providers are included in this draw.

4. Only Northland residents who have been recorded in the COVID-19 Immunisation Register as having had two doses of vaccine by 10 December 2021, will be included in The Christmas Draw on 15 December 2021. All Northland DHB staff, primary care and community health providers are included in this draw.

6. You can request to be excluded from the draws by emailing Your full name, date of birth, and postal address to communications@northlanddhb.org.nz.

7. If You receive a gift valued at \$500 or more, You will be excluded from further draws.

How gift recipients are selected

10. During the term of Campaign, gift recipients for the different gifts will be drawn randomly from the COVID-19 Immunisation Register. Gift recipients may be drawn from different geographic areas, including: Whangārei, Kaipara, Mid North, and Far North, as well as other specific areas in Northland that We may decide to include.

11. Gift recipients will be contacted using the contact details provided in the COVID Immunisation Register.

12. If You are drawn and we are unable to contact You within two days of the notification by using the contact details You have provided the gift will be forfeited. In these circumstances, we reserve the right to draw a new recipient for the gift.

13. Our determination of the gift recipient and the exclusion of any person from the draw will be final and binding, and no correspondence or other communication will be entered into.

14. Northland DHB reserves the right to change the gifts at any time.

Use of image and privacy

15. If You win a gift in the Campaign, we may ask to use Your name and image for promotional and media purposes and to participate in any promotional events, in each case without compensation.

16. If You are a recipient of a gift You consent to us providing Your name and contact details to the relevant partner that We are working with in relation to the gift, who will contact You regarding redemption and delivery of the gift. You agree that the gift will be provided to You at an appropriate COVID-19 Alert Level as determined by the partner and in accordance with any redemption and delivery terms and conditions they may have.

If You are a Gift Recipient

17. The gifts cannot be redeemed for cash and cannot be transferred or exchanged. If a gift is not available for any reason, we reserve the right to substitute the gift with another gift of similar value.

18. Gifts may be subject to additional terms and conditions by Our partners, for example, vouchers may have additional terms and conditions and/or and expiry date. Expenses such as but not limited to, travel to accommodation, travel insurance, meals, spending money, and other associated expenses are the sole responsibility of the gift recipient

19. The gift is taken entirely at the gift recipient's own risk. The gift recipient is responsible for any tax or other costs arising in relation to or associated with the gift. You acknowledge that (to the extent permitted by law) we are not liable, and You release and indemnify us and any persons associated with the draw in respect of any claim, for any accident, injury, death, property damage and other losses that may occur in connection with the draw or any gift.

Miscellaneous terms

20. We reserve the right to cancel or amend the Campaign and associated promotion at Our sole discretion.

21. This Campaign and these terms and conditions will be governed by New Zealand law and any disputes will be subject to the exclusive jurisdiction of the courts of New Zealand.
